

2011 kept the Township busy.

Empire gave out 16 new single family house permits which has almost doubled from 2010. Along with the building of these new homes, our ballfields are being completed. Empire is planning that by 2013 they will be operational.

A rental agreement for the Public Works meeting room has been completed and approved.

Fischer Sand and Aggregate was issued a Mineral Extraction permit. The area was rezoned from Agricultural Preservation to ME – Mineral Extraction.
