A copy of this permit must be kept with the vehicle at all times and displayed upon demand of any peace officer or officers of Dakota County. All Minnesota Statutes and Department of Public Safety Regulations must be complied with. Empire Township issues this permit to be oversize but does not guaranty the clearances needed for your load—you must inspect your route. Permission is granted for the above movement under provisions of Chapter 169.86 of the Minnesota Highway Traffic Regulation Act subject to the following special requirements:

8'6" to 10' Wide

1. 24-hour movement including nights, weekends and holidays. No traffic signage required.

10' to 14'6" Wide

1. Mon. – Thu. Permitted travel from 2:00a.m. to 10:0 p.m., Fridays and/or the day before a weekday holiday from 2:00a.m. to 2:00p.m., Saturdays from 2:00a.m. to 10:00p.m. and Sundays from 2:00a.m. to 2:00p.m.
2. Exception – No movement is allowed in the Cities of Apple Valley, Burnsville, Eagan, Farmington, Hastings, Inver Grove Hts., Mendota, Mendota Hts., Rosemount, So. St. Paul, Sunfish Lake and West St. Paul between the hours of 6:00a.m. to 8:30a.m. and 3:30p.m. to 6:00p.m. on weekdays. No holiday or holiday weekend travel.
3. Red, orange or yellow Day-glow flags a minimum of 18"x18" at all four corners of the load.
4. Over 14' wide: wide load signs front and rear on loads and illuminated at night. No travel on two-lane highways when shoulders are soft or where no shoulders exist. On wide load warning escort vehicle is required.

Over 14'6" Wide

1. Movement by route designation only. Notify County Sheriff, check on weather and road conditions.
2. Permitted night travel between 2:00 a.m. to 6:00 a.m. No holiday or holiday weekend travel.
3. Escort vehicles front and rear with wide load warning signs. Illuminated wide load signs front and rear of the load.
4. Escort vehicle must carry approved rotating or flashing amber beacons and allow traffic to pass periodically.

Total length of 95', under 110' Long load sign mounted in front of load, escort vehicle following with long load sign.

Total Length of 110' Escort vehicles front and rear with long load signs.

Overhang protection more that 3' ahead or 4' behind the truck or trailer requires 18" x 18" flagging. Overhangs shall not exceed 30' front or rear. No night movement without lights on the ends and every 20' a long the sides.
